#### STEYsha School of Irish Dance Rules

- 1. To register, you will fill in the form attached to the Rules. Registration is equivalent to declaring that the new student is medically fit for sustained physical activity.
- 2. The information provided upon registration will only be used within the school, with the sole purpose of facilitating the student's activity in the school. The student's personal information will not be shared with any third party, except in very isolated cases and only with the student's explicit consent and it will be updated through yearly re-registration.
- 3. The student's phone number, e-mail address and the Facebook account listed on the registration form will be used for school student communication. The student can opt out of receiving any messages of general interest for the school, thus assuming that they are limiting their own access to this information.
- 4. The filled-in form and signed rules need to be sent in advance via e-mail or are handed personally at the dance studio before the first class. When registering, the new student receives a student card used for keeping track of their monthly payments.
- 5. Each year, the students will fill-in a new re-registration form for the season *current September next September*. There is a non-refundable registration and re-registration fee of 25 RON per dancer/family.
- 6. At the beginning of each month, the student will pay the **fixed fee** according to the frequency they opt for. **The monthly fee is compulsory, non-refundable and non-negotiable**. If, for reasons that are not due to the school, the student misses classes, **the fee is not reported** to the next month. The monthly fee is **non-transmissible**, even within the same family.
- 7. **In order to choose the right fee, consider the following: frequency and class = 60 minutes.** So, if a dancer only does soft shoes with a once a week frequency, they will pay the fee for one weekly class. A dancer doing both soft shoes and hard shoes, with a once a week frequency will pay the monthly fee for two weekly classes.
- 8. The fee is paid in cash or by bank transfer on the first day of the month, no later than the 10<sup>th</sup> of the month. Otherwise, there will be a late fee of 25 RON per person/ family, and the dancer will only be able to assist and not actively participate in class until payment is done. Asociația "STEYsha School of Irish Dance" functions through self-funding. Failure to comply with the payment deadlines and rules may lead to difficulties in the proper functioning of the school and may affect the class schedule.
- 9. If the dancer cannot attend classes, they must inform the school at least 2 hours ahead of class time. Missing classes does not allow the payment to be carried out (reported) to the next month. Announcing they would miss class, allows the student to recover the number of missed classes within the next month. Missing unannounced does not allow class recovery. Missing 4 or more consecutive classes leads to the automatic deactivation of the student (removal from the communication lists and from any future events they had already enrolled in) and requires reregistration and payment of the re-registration fee once the student decides to come back to class.
- 10. The school continues its activity throughout summer. The same frequency and fee rules apply.
- 11. The classes are 45 minutes long in the case of Mini-Irish and 60 minutes long in the case of all other classes and students need to in the dance studio at least 10 minutes before class-time.
- 12. Sports attire is compulsory: school T-shirt/ plain T-shirt/ top, skirt/ skort/ shorts/ decent tights, black canvas ballet slippers/ soft shoes and heavy shoes. No street clothes and no neon colours or stripped patterns. Parents of little ones are asked not to leave them only in their underwear as class attire, as well as change them only in the changing areas. For the dancer's thermal comfort, their class attire needs to be in accordance with the seasons.

- 13. Jewellery, other accessories and phones will stay in the changing area during class.
- 14. Do not spray perfume or deodorant in the studio. Kindly use roll-on or stick deodorant if you wish to freshen up at the studio. Use of deodorant is compulsory from 9 years up. Long hair will be worn in a pony tail or a bun during class.
- 15. The school T-shirts/ hoodies, feis and performance costumes, dance shoes as well as other necessary equipment can be purchased through or with the help of the school, but their costs are covered solely by the student. The school does not owe cost coverage to any of the students. The purchased equipment is used only by the individual and is not a common good.
- 16. Rented or borrowed school shoes and/or costumes cannot be taken out of the dance studio with the school approval and they are returned promptly within the notified deadline. The equipment rental fee is paid on the spot, cash or through bank transfer and is renewed each time it is applicable (e.g.: dance shoes and solo dresses are rented for a maximum of 1 year, after which a new fee is paid).
- 17. Street shoes are strictly forbidden in the dance studio!
- 18. Family cannot intervene during class, unless asked otherwise.
- 19. Intellectual rights/copyright on steps and choreographies belong exclusively to Asociația STEYsha School of Irish Dance & ISTA School (our Polish partner) no one else aside the school teacher can have any claims on them. By using this material outside any events agreed upon with the school or after transferring to another school or dancing group may bring upon legal actions against the dancer. STEYsha School of Irish Dance reserves the right to use any legal means should this rule be breached.
- 20. Attending Irish Dancing classes held by another registered or non-registered teacher/school/dancing group or dancing in any projects/events/performances held by the before mentioned without the teacher's agreement means that the student can immediately be banned from the school.
- 21. Transferring to another Irish Dancing school will bring the dancer under the CLRG & RCCEA transfer rule: 6 months ban from feiseanna and the definite interdiction from further using the school's steps and choreographies in any type of event, be it local or international. Legal actions may be taken otherwise.
- 22. Any photo or video footage of the school containing images of former or current students, as well as the right to use them belong to Asociația STEYsha School of Irish Dance. The school is committed to using this material strictly for self promotion, as well as promotion of Irish culture in Romania and within the international Irish dance community.
- 23. The student may opt for their image not to be used for the above-mentioned purposes, thus assuming the possibility of them being excluded from situations in which photography and video recording, as well as public posting of the footage is unavoidable.
- 24. The school is entitled to choose its students.
  - $\circ$  I opt NOT to receive any phone/ e-mail/ Facebook message and NOT to be included in the school mailing list. I understand that this will limit my access to school information.
  - o I DO NOT wish for my image (photo and/ or video) to be used for the purpose of promoting STEYsha School of Irish Dance, Irish dance and culture. I understand that this may lead to my being excluded from situations and events where picture and video taking of the school and dancers cannot be avoided.

#### **Class Fees 2018 – 2019**

Registration/ re-registration fee: 25 RON per student/ family

**Late fee**: 25 RON per student/ family – it applies every month that payment is done later than the 10<sup>th</sup>.

1 class paid individually: 50 RON 1 private class (60 min.): 50 RON

Soft & hard shoes rental: 100 RON/ year\* Solo dress rental: 200 RON/ year\* (\*only to school students)

PAYMENT IS DONE AT THE BEGINNING OF THE FIRST CLASS OF THE MONTH, NO LATER THAN THE 10<sup>TH</sup> OF THE MONTH. Otherwise, the late fee applies.

The fees are fixed, non-negotiable and apply to all students. No other discounts are applied.

Payments are done in cash or by bank transfer and are compulsory, non-refundable, non-reportable, non-transmissible (even within the same family).

Missing classes does not allow the current payment to be carried out (reported) to the next month. Announcing they would miss class, allows the student to recover the number of missed classes within the next month. Missing unannounced does not allow class recovery. Missing 4 or more consecutive classes leads to the automatic deactivation of the student and requires re-registration and payment of the re-registration fee once the student decides to come back to class.
